Federal Board of Revenue (FBR) has introduced major amendments in the Tax Laws recently; especially in The Income Tax Rules 2002 & The Sales Tax Rules 2006, by issuing SRO 350 of 2024 which establishes a critical link between buyer's tax return filing and their suppliers' compliance and SRO 457 of 2024 to Introduce "Tajir Dost Scheme" Special Procedure for Small Traders and Shopkeepers. Moreover, amendments in the Income Tax Ordinance, 2001 were also issued through the Tax Laws Amendment Bill, 2024.




